1. The purpose of this document is to establish an agreement between PERFECT PARTNERS Video Production, (hereafter called COMPANY) and _____ (hereafter called CLIENT), for the production of a Wedding Video DVD.

Total is payable as follows:

- a. \$250.00 at agreement signing, due receipt of which is hereby acknowledged by Company
- b. \$100.00 per month after agreement signing, payable on the 1st of each month. No invoices will be sent out.
- c. Whenever video package is paid, all honeymoon pictures and music are delivered to Company, final production will begin.
4. Company shall provide a Wedding Day Worksheet to Client to prepare Company for the event. Client agrees to provide all materials to Company no later than one month prior to the event. Company is not responsible fore elements not provided by Client. Materials not received prior to the event will be omitted from finished version of wedding videotape.
5. Client shall request any deviations or changes no later than 10 days prior to event. Changing the calendar date is subject to space available, and no fee will be charged for this service. Client agrees to a 50% non-refundable booking fee for cancellation of event. This includes cancellation resulting from Client's changing a scheduled date, which conflicts with Company's full scheduled bookings.
6. Client agrees that Company's liability to the Client shall not exceed the amount paid by the Client to the Company under this agreement and shall in no event include incidental or consequential damages, including, without limitation, lost profits.
7. I hereby release, discharge, and agree to save Company from any liability by virtue of any blurring, distortion, alteration, optical illusion, or use in composite form, distorted or interfered audio, whether intentional or otherwise, that may occur or be produced in the taking of said pictures, or in any processing tending towards the completion of the finished product.
8. Should I decide to extend the videographer into overtime, I agree to add the sum of \$95.00 per additional hour. I understand that I can make this decision on the day of the event.
9. Client agrees that "Hours on Location" as stated in description of video above begins no later than two hours prior to ceremony start time to provide adequate time for pre-ceremony requirements.
10. Client understands Rehearsal attendance is not included in this video package but may be added as an option. Client agrees that if he/she chooses not to request the Videographers presence at rehearsal, then Videographer will have full discretion as to camera placement at ceremony.

I ACKNOWLEDGE UPON SIGNING THIS CONTRACT THAT I HAVE CAREFULLY READ, UNDERSTOOD AND AG4REED TO EACH AND EVERY PROVISION. I HAVE NOT RELIED UPON ANY STATEMENTS, PROMISES OR REPRESENTATIVES OTHER THAN CONTAINED HEREIN AND ACKNOWLEDGE RECEIPT OF COPY OF THIS CONTRACT. CONTRACT BECOMES VALID UPON ACCEPTANCE OF BOOKING FEE BY CHECK OR CASH PAYMENT. ALL SALES ARE FINAL.
